HB67	Carter, R.	TAX/FUELS, SPECIAL	Imposes a tax on all oil and gas that runs through pipelines located in the state <ul style="list-style-type: none">- Read by title. Lies over under the rules.
HB68	Carter, R.	TAX/TAXATION	(Constitutional Amendment) Authorizes the levy of a tax on the use of hydrocarbon processing facilities <ul style="list-style-type: none">- Read by title. Lies over under the rules.
HB69	Armes	TAX/INCOME-CREDIT	Suspends the Louisiana Citizens Property Insurance Corporation assessment income tax credit (Item #26) <ul style="list-style-type: none">- Read by title, rules suspended, referred to the Committee on Ways and Means.
HB70	Carter, R.	TAX/TAXATION	(Constitutional Amendment) Removes the prohibition related to the imposition of an additional tax or license on gas, authorizes the levy of a tax, fee, permit, or license on natural gas transported in Louisiana, and creates the Fair Share Fund <ul style="list-style-type: none">- Read by title. Lies over under the rules.
HB71	Barras	TAX CREDITS	Reduces the amount of certain Enterprise Zone tax credits and removes certain hotels from eligibility (Item #27) <ul style="list-style-type: none">- Read by title, rules suspended, referred to the Committee on Ways and Means.
HB72	Shadoin	TAX/SALES-USE, STATE	Increases the state sales tax on telecommunications services (Item #24) <ul style="list-style-type: none">- Read by title, rules suspended, referred to the Committee on Ways and Means.
HB73	Morris, Jay	TAX/INCOME TAX	Requires that certain deductible items be added-back on certain corporate income tax returns (Item #5) <ul style="list-style-type: none">- Read by title, rules suspended, referred to the Committee on Ways and Means.
