HB2	Broadwater	TAX CREDITS	Repeals the Student Assessment for a Valuable Education (SAVE) credit program (Item #14) - Read third time by title, roll called on final passage, yeas 95, nays 0. Finally passed, title adopted, ordered to the Senate.
HB67	Carter, R.	TAX/FUELS, SPECIAL	Imposes a tax on all oil and gas that runs through pipelines located in the state - Read by title, returned to the calendar.
HB68	Carter, R.	TAX/TAXATION	(Constitutional Amendment) Authorizes the levy of a tax on the use of hydrocarbon processing facilities - Read by title, returned to the calendar.
HB70	Carter, R.
