- HB2 Abramson CAPITAL OUTLAY
Provides for the comprehensive Capital Outlay budget (Item #3)
- Reported favorably (18-0).
 - Rules suspended.
 - Read by title, passed to 3rd reading.
 - Rules suspended.
 - Notice given.
 - Scheduled for floor debate on 06/09/2016.
 - Read third time by title, amended, roll called on final passage, yeas 90, nays 8. Finally passed, title adopted, ordered to the Senate.
- HB3 Abramson CAPITAL OUTLAY
Provides for the Omnibus Bond Act (Item #4)
- Read by title, returned to the calendar.
 - Notice given.
 - Scheduled for floor debate on 06/15/2016.
- HB5 Leger TAX/CORP INCOME
Provides with respect to the applicability and effectiveness of Act Nos. 30 and 31 of the 2016 First Extraordinary Session of the Legislature which eliminated the deductibility of federal income taxes paid for purposes of computing corporate income taxes (Items #39 & 40)
- Reported favorably (15-2).
 - Rules suspended.
 - Read by title, ordered engrossed, passed to 3rd reading.
 - Scheduled for floor debate on 06/13/2016.
- HB6 Leger TAX/INCOME TAX
Provides with respect to the applicability and effectiveness of Act No. 8 from the 2016 First Extraordinary Session of the Legislature which established a flat rate for purposes of calculating corporation income tax liability (Item #38)
- Reported favorably (18-0).
 - Rules suspended.
 - Read by title, ordered engrossed, passed to 3rd reading.
 - Scheduled for floor debate on 06/13/2016.
- HB7 Stokes TAX/INCOME TAX
(Constitutional Amendment) Eliminates the income tax deduction for federal income taxes paid for purposes of computing individual income taxes and the references to the maximum amount of individual income tax rates and brackets (Items #39 & 43)
- Reported without amendments (5-0-1).
 - Rules suspended.
 - Read by title, passed to 3rd reading.
 - Scheduled for floor debate on 06/13/2016.
- HB8 Magee TAX/SALES-USE, ST-EXEMPT
Provides for effectiveness of the exemption for purchases of fishing vessels, supplies, fuels, lubricants, and repairs for vessels by licensed commercial fishermen (Item #33)
- Read by title, returned to the calendar.

- HB47 Broadwater TAX/CORP INCOME
Provides with respect to the net operating loss deduction for corporate income tax (Item #37)
- Read third time by title, amended, roll called on final passage, yeas 93, nays 1. Finally passed, title adopted, ordered to the Senate.
- HB50 Montoucet TAX/INCOME TAX
Reduces the individual income tax deduction for net capital gains (Item #41)
- Reported with amendments (14-0).
- Rules suspended.
- Read by title, amended, ordered engrossed, passed to 3rd reading.
- Scheduled for floor debate on 06/13/2016.
- HB51 Morris, Jim TAX/SALES-USE, STATE
Provides with respect to the effectiveness of certain exclusions and exemptions from state sales and use taxes (Items #7-34)
- Read third time by title, amended, roll called on final passage, yeas 100, nays 0. Finally passed, title adopted, ordered to the Senate.
- HB52 Abramson CAPITAL OUTLAY
Provides with respect to the execution and administration of capital outlay appropriations for Fiscal Year 2016-2017 (Item #3)
- Read third time by title, amended, roll called on final passage, yeas 96, nays 0. Finally passed, title adopted, ordered to the Senate.
- HB53 Abramson TAX
Provides with respect to sales of certain services and tangible personal property at certain publicly owned facilities (Item #35)
- Read third time by title, amended, roll called on final passage, yeas 98, nays 0. The bill, having received two-thirds vote of the elected members, was finally passed, title adopted, ordered to the Senate.
- HB65 Schroder TAX EXEMPTIONS
Requires the appropriation of certain tax expenditures (Item #47)
- Read by title, rules suspended, referred to the Committee on Appropriations.
- HB66 Harris, J. TAX/SALES-USE-EXEMPT
Provides relative to state and local sales and use tax exemptions for sales at publicly owned domed stadium facilities, baseball facilities, and other facilities (Item #35)
- Read by title, rules suspended, referred to the Committee on Ways and Means.
- HR1 Smith, P. COMMENDATIONS
Commends the Girlfriends Pray ministry for encouraging, inspiring, motivating, and empowering women through prayer
