SB12 Fesi UNCLAIMED PROPERTY  
Constitutional amendment to dedicate unclaimed property funds and to create the Louisiana Unclaimed Property Permanent Trust Fund.  
(2/3 - CA13s1(A)) (Item #10) (7/1/21)

- Read third time by title, roll called on final passage, yeas 95, nays 3. The bill, having received two-thirds vote of the elected members, was finally passed, ordered to the Senate.

SB18 Fesi FUNDS/FUNDING  
Dedication of unclaimed property funds and creation of Louisiana Unclaimed Property Permanent Trust Fund. (Item #10) (See Act)

- Read third time by title, roll called on final passage, yeas 98, nays 3. Finally passed, ordered to the Senate.

SB19 Peacock FUNDS/FUNDING  
Provides for investment authority of the Treasurer for the Millennium Trust, the Rockefeller Wildlife Refuge Trust and Protection Fund, and the Russell Sage or Marsh Island Trust Fund. (Item #10) (7/1/20)

- Read third time by title, roll called on final passage, yeas 101, nays 0. Finally passed, ordered to the Senate.

SB24 Harris, Jimmy TAX/TAXATION  
Provides for eligibility for the Angel Investor Tax Credit for investments made in federal opportunity zones. (Item #19) (gov sig)

- Reported favorably (15-0). Referred to the Legislative Bureau.  
- Reported without Legislative Bureau amendments.  
- Rules suspended.  
- Read by title, passed to 3rd reading.  
- Scheduled for floor debate on 06/28/20.

SB27 White, B STATE AGENCIES  
Creates and provides for the Streamlining Government Commission.  
(Item #33) (gov sig)
