SB203	White, B	ETHICS	Exempts certain groundwater district commissioners from provisions of the Code of Governmental Ethics. (gov sig) - Notice Senate's motion to override the Governor's veto failed to pass.
SB220	Cloud	LEGISLATIVE AUDITOR	Provides relative to the legislative auditor examinations, audits, and reviews of elections and retention of election records. (See Act)
