HB 1 HAMMETT TAX/SALES-USE, ST-EXEMPT
Makes inapplicable, inoperable, and of no effect certain exemptions to the tax

HB 2 HAMMETT TAX/SALES & USE
Exempts certain machinery and equipment from the tax

HB 27 DANIEL TAX/SALES-USE, STATE

Repeals the corporate franchise tax
