Provides for an increase in the base amount of mineral revenues that are deposited annually in the Budget Stabilization Fund. (gov sig) (2/3-CA7s10.3(A)(2)(b))  
Received in the House from the Senate, rules suspended, read by title.
- SB 9 MOUNT TAX/TAXATION  
Extends income/franchise tax credit for the rehabilitation of historic structures located in a downtown development district. (7/1/02)  
Received in the House from the Senate, rules suspended, read by title.
- SB 13 MOUNT TAX EXEMPTIONS  
Provides for an immediate reduction of the state sales and use tax for certain fuels or gases purchased for residential use by the consumer beginning July 1, 2004. (7/1/04)
