HB1 Greene TAX/SALES-USE, STATE

Provides relative to the effectiveness of the state sales and use tax exemption for sales of electricity, natural gas, water, and steam (Item #2)

HB5 Tucker TREASURY DEPARTMENT

HB6 Dove FUNDS/FUNDING

Provides for the deposit of monies into the Coastal Restoration and Protection Fund (Item #11)

- Reported without Legislative Bureau amendments, read by title and passed to a third reading.

HB9 Richmond TAX CREDITS

Increases the total aggregate amount of credits that may be taken under the new markets tax credit (Item #5)

- Reported without Legislative Bureau amendments, read by title and passed to a third reading.

HB18 Greene TAX/INCOME TAX

Provides that certain federal income tax rebates or credits shall not reduce the federal income tax deduction (Item #12)
