- SB 59** **BUFFINGTON** **POSTSECONDARY ED** Requires the boards of supervisors for the Louisiana State University, Southern University, University of Louisiana and Louisiana Community and Technical College systems to broadcast the live audio and video of all board and committee meetings conducted in Baton Rouge on the Internet. (1/1/14)
- SB 117** **APPEL** **POSTSECONDARY ED** Provides for the creation of the Outcomes-Based Funding Task Force. (gov sig)
- SB 118** **APPEL** **POSTSECONDARY ED** Provides relative to the use, expenditure, or allocation of funds appropriated to public postsecondary education management boards. (gov sig)
- SB 202** **NEVERS** **TOPS** Revises core curriculum requirements and the method of calculating the grade point average for TOPS awards. (gov sig)
- SB 229** **BROOME** **FUNDS/FUNDING** Provides that the Louisiana Education Quality Trust Fund shall be known as the "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund." (gov sig)
