- SB 54 BROOME STUDENTS** Prohibits suspension or expulsion of students in grades kindergarten through three. (gov sig)
- SB 69 NEVERS EDUCATION DEPARTMENT** Requires the Dept. of Education to pay the cost of certain postsecondary remedial and developmental coursework required of public high school graduates. (gov sig)
- SB 129 NEVERS SCHOOLS** Authorizes a local public school district to enter into an agreement with a higher-performing district to manage and operate one or more of its low-performing schools. (gov sig)
- SB 184 THOMPSON, FRANCIS SCHOOLS** Provides for the threshold allowed for small purchase procurements under food and nutrition programs. (8/1/15)
