**U.S. CONSTITUTION** Applies to congress under U.S. Const. Art. V to call a convention of the states to propose U.S. constitutional amendments to impose fiscal restraints on the federal government, limit federal government power, and provide for term limits for federal officials and members of congress

**HCR 117 CHANEY**

**JUVENILE PROCEDURE** Authorizes and directs the La. State Law Institute to study the issue of restitution in

delinquency cases and to report its findings to the La. Legislature

- HCR 175 JEFFERSON**      **CORRECTIONS** Requests the Department of Public Safety and Corrections to develop a work release program for persons convicted of offenses involving the failure to pay child support
- HB 34 DOVE**      **DISTRICT ATTORNEYS/ASST** Provides relative to the annual salary of certain assistant district attorneys
- HB 281 HILL**      **INSURANCE/GROUP-SHERIFFS** Provides relative to the payment of group insurance premiums for retired sheriffs and deputy sheriffs hired on or after July 1, 2015, for Allen Parish
- HB 392 LOPINTO**      **LAW ENFORCEMENT** Creates a database for certain training and hiring information for all law enforcement officers
- HB 475 LOPINTO**      **GAMBLING** Provides with respect to fantasy or simulation games
- HB 477 MONTOUCET**      **TOBACCO/TOBACCO PRODUCTS** Provides for minimum pricing of cigarettes
- HB 842 MORENO**      **DOMESTIC ABUSE** Provides relative to domestic abuse
