20 **Article shall have the right to have a parent, tutor, or legal guardian**
21 **present during the examination. If such person cannot be present, the**
22 **court shall order the examination to be videotaped at the expense of the**
23 **party being examined. The court shall consider the best interests of the**
24 **minor and may impose conditions upon videotaping, including that it be**
25 **done in a manner least harmful to the minor and without disclosure to**
26 **the minor.**"
