Provides relative to mandatory training for peace officers related to human trafficking. (8/1/22)

Proposed law requires that within one year of employment, all peace officers shall receive seven (7) hours of training on human trafficking from the Council on Peace Officers Standards and Training (POST) online Learning Management System program. Requires all peace officers employed on August 1, 2022, who have been employed for one year or more, to receive training by December 31, 2022. Beginning in 2023, the POST Council shall report compliance percentages of human trafficking training to the Senate Committee on Judiciary B and the House Committee on the Judiciary each year by February 15.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The LA Commission on Law Enforcement has already produced seven training modules on human trafficking on behalf of the Peace Officers Standards and Training Council. The proposed legislation will make the completion of the training modules by peace officers mandatory, instead of voluntary. The training for human trafficking prevention is online. LCLE updates the training periodically and has thus far been able to utilize federal grant funds to produce the training modules.
