16 (B) The provisions of R.S. 39:1595.4(C) and (D) of Section 6 of this
17 Act shall become effective on January 1, 2011.

18 Section 19. On or before July 1, 2011, and on or before July 1, 2012,
19 the Department of Health and Hospitals and Louisiana Workforce
20 Commission jointly shall submit a report to the House Committee on Health
21 and Welfare and the Senate Committee on Health and Welfare indicating the
22 actual cost of implementing the provisions of this Act."

23 Section 20. Except as provided in Section 18, this Act shall become
24 effective on July 1, 2010; if vetoed by the governor and subsequently
25 approved by the legislature, except as provided in Section 18, this Act shall
26 become effective on July 1, 2010, or on the day following such approval by
27 the legislature, whichever is later."
