DRUGS/PRESCRIPTION: Provides relative to the prescribing, administering, and dispensing of drugs for off-label use

| 11 | A. As used in this Section, the following terms have the following meanings:               |
| 12 | (1) "FDA" means the United States Food and Drug Administration.                            |
| 13 | (2) "Off-label use" means the use of a prescription drug for an indication for             |
| 14 | which it has not been approved by the FDA or the use of such drug in an age group,         |
| 15 | dosage, or route of administration that has not been approved by the FDA.                  |
| 16 | B. No healthcare professional licensing board or commission created by the                 |
| 17 | provisions of this Title shall prohibit or restrict the prescribing, administering, or     |
| 18 | dispensing for an off-label use of a drug that has been approved for a specific use by     |
| 19 | the FDA.   |

Abstract: Provides that no healthcare professional licensing board or commission of the state shall prohibit or restrict the prescribing, administering, or dispensing of drugs for off-label use.

<u>Present law</u> provides for licensure and regulation by the state of various types of healthcare professionals.

<u>Proposed law</u> retains <u>present law</u> and provides that no healthcare professional licensing board or commission shall prohibit or restrict the prescribing, administering, or dispensing for an off-label use of a human drug that has been approved for a specific use by the U.S. Food and Drug Administration (FDA).

<u>Proposed law</u> defines "off-label use", for purposes of <u>proposed law</u>, as the use of a prescription drug for an indication for which it has not been approved by the FDA or the use of such drug in an age group, dosage, or route of administration that has not been approved by the FDA.
