7	Section 1. R.S. 6:333(F)(13) is hereby amended and reenacted to read as follows:
8	§333. Disclosure of financial records; reimbursement of costs

10	F. The following disclosures by a bank or any affiliate are hereby specifically
11	authorized and, except as otherwise provided in this Subsection, nothing in this

<u>Present law</u> prohibits the disclosure by a bank or its affiliate of financial records to any person other than the customer to whom the financial records pertain, except as provided by <u>present law</u>.

<u>Present law</u> provides for an exception to <u>present law</u> for the disclosure by a bank or an affiliate of financial records pursuant to a subpoena or court order issued in connection with a federal or state court grand jury proceeding or a state criminal investigation.

<u>Proposed law</u> retains <u>present law</u> and further provides for an exception to a subpoena issued by the state inspector general or any member of his staff designated by him pursuant to <u>present law</u>.

Effective August 1, 2025.
