Abstract: Prohibits the use of certain rating factors in insurance underwriting.

Present law prohibits inadequate or unfairly discriminatory rates in a competitive market.

<u>Present law</u> prohibits rates from being excessive, inadequate, or unfairly discriminatory in a noncompetitive market.

<u>Present law</u> authorizes risk classification based on any criteria except race, color, creed, or nation origin.

<u>Proposed law</u> retains <u>present law</u> and further prohibits risk classification based on a person's education level or credit information.

Present law regulates the use of credit information for personal insurance.

Proposed law repeals present law.
