Constitutional amendment to provide for foreign donations in elections. (2/3 - CA13s1(A))

Proposed constitutional amendment prohibits the use of funds, goods, or services donated by a foreign government, entity, or noncitizen to promote any ballot initiative, candidate, issue, political party, or proposition.

To be submitted to the electors at the statewide election to be held on November 15, 2025.

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed constitutional amendment prohibits the use of funds, goods, or services donated by a foreign government, entity, or noncitizen to promote any ballot initiative, candidate, issue, political party, or proposition.

Currently, the November 15, 2025 election date is scheduled as an open/Orleans municipal parochial general election. While this legislation does not direct the conversion of this election to a statewide ballot to facilitate the inclusion of this constitutional amendment, the Secretary of State reports that it would require an additional \$3 M SGF in FY 26 to make this transition for all parishes and precincts.
