INSURANCE/GROUP-SHERIFFS Provides relative to qualifications for participation in the Employee Insurance Fund for the Jefferson Davis Parish Sheriff's Office

Purpose of Bill: This bill changes eligibility requirements of group insurance premium costs paid by the Jefferson Davis Parish Sheriff's Office (JDPSO) for retired sheriffs and deputy sheriffs who were hired on or after July 1, 2018. This bill will change the requirements from at least 15 years of service with JDPSO and at least 55 years of age to either (1) at least 15 years of service with at least 12 years being with JDPSO and at least 55 of age or (2) at least 30 years of service with at least 12 years being with JDPSO at any age.
