7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 22:1483.1(F) is hereby enacted to read as follows:
9	§1483.1. Louisiana Fortify Homes Program

11	F. Grant amounts received on or after January 1, 2025, shall be exempt
12	from inclusion in the recipient's taxable income for purposes of state individual
13	income tax as provided in R.S. 47:293(9)(a)(xxvii).
14	Section 2. R.S. 47:293(9)(a)(xxvii) is hereby enacted to read as follows:
15	§293. Definitions
16	The following definitions shall apply throughout this Part, unless the context
17	requires otherwise:

2	(9)(a) "Tax table income", for resident individuals, means adjusted gross
3	income plus interest on obligations of a state or political subdivision thereof, other
4	than Louisiana and its municipalities, title to which obligations vested with the
5	resident individual on or subsequent to January 1, 1980, and less:

7	(xxvii) Grant amounts received from the Louisiana Fortify Homes
8	Program pursuant to R.S. 22:1483.1 on or after January 1, 2025.

10	Section 3. This Act shall become effective upon signature by the governor or, if not
11	signed by the governor, upon expiration of the time for bills to become law without signature
12	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
13	vetoed by the governor and subsequently approved by the legislature, this Act shall become
14	effective on the day following such approval.

Present law authorizes the Louisiana Fortify Homes Program which authorizes the commissioner of insurance to provide financial grants of \$10,000 to retrofit roofs for insurable properties that have a homestead exemption to provide a fortified roof that meets or exceeds the fortified roof standard of the Insurance Institute for Business and Home Safety.

Proposed law retains present law.

Proposed law authorizes an individual income tax exemption for the grant amount received from the Louisiana Fortify Homes Program on or after January 1, 2025.

Effective upon signature of the governor or lapse of time for gubernatorial action.
