21 effective when Act No. 384 of the 2013 Regular Session of the Legislature becomes
22 effective.

23 (C) Section 22 of this Act shall become effective July 1, 2026.

24 (D) Sections 1 through 4, 7, 8, 10 through 18, and 23 of this Act shall become
25 effective July 1, 2027, or when no more than one million dollars in additional
26 recurring state general funds is necessary to implement the provisions of this Act,
27 whichever occurs later."
