"G. Miscellaneous. Unless specifically excepted or contained within a 17 pharmaceutical product approved by the United States Food and Drug 18 19 Administration, or unless listed in another schedule, any material, compound, mixture, or preparation which contains any quantity of the following substance 20 substances, including its their salts, isomers, or salts of isomers, whenever the 21 22 existence of such salts, isomers, or salts of isomers is possible within the specific 23 chemical designation: 24

- (1) Tianeptine 7-hydroxymitragynine
- (2) Mitragynine
- (3) Tianeptine"

28 On page 2, delete lines 11 through 24 and insert:

29	"A. For purposes of this Section, "kratom" means any substance derived
30	from the leaves of the Mitragyna speciosa tree or any substance containing 7-
31	<u>hydroxymitragynine or mitragynine.</u>
32	B.(1) Manufacture; distribution. It shall be unlawful for any person to
33	knowingly produce, manufacture, distribute, or dispense, or possess with intent
34	<u>to produce, manufacture, distribute, or dispense, kratom.</u>
35	(2) Any person who violates Paragraph (1) of this Subsection for an
36	amount of:

1	(a) An aggregate weight of less than five hundred grams, shall be fined
2	not more than fifty thousand dollars, imprisoned, with or without hard labor,
3	for not less than one year nor more than three years, or both.
4	(b) An aggregate weight of five hundred grams or more, shall be fined
5	not more than fifty thousand dollars, imprisoned, with our without hard labor,
6	for not less than one year nor more than five years, or both.
7	C. Possession. It is unlawful for any person knowingly or intentionally
8	to possess kratom unless it was obtained directly from a practitioner or
9	pursuant to a valid prescription or order from a practitioner as provided in R.S.
10	40:978 while acting in the course of his professional practice, or except as
11	otherwise authorized by this Part. Any person who violates this Subsection shall
12	be punished as follows:
13	(1) On a conviction wherein the offender possesses twenty grams or less,
14	the offender shall be fined not more than one hundred dollars.
15	(2) On a first conviction, wherein the offender possesses more than
16	<u>twenty grams, the offender shall be fined not more than five hundred dollars,</u>
17	imprisoned in the parish jail for not more than six months, or both.
18	(3) On a second or any subsequent conviction, wherein the offender
19	possesses more than twenty grams, the offender shall be fined not more than
20	one thousand dollars, imprisoned in the parish jail for not more than six
21	months, or both.
