ECONOMIC DEVELOPMENT. Provides relative to financial incentives for events held in Louisiana. (7/1/25)

1	AN ACT
2	To amend and reenact R.S. 51:1260(C)(5) and (6), (E), (F), and (G) and to enact R.S.
3	51:1260(H) and 1261, relative to financial incentives for events held in Louisiana;
4	to provide for qualifying major events; to provide for definitions; to provide for
5	eligibility requirements; to create a grant program for certain Louisiana events; to
6	provide for administration of the program; to provide for an effective date; and to
7	provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 51:1260(C)(5) and (6), (E), (F), and (G) are hereby amended and
10	reenacted and R.S. 51:1260(H) and 1261 are hereby enacted to read as follows:
11	§1260. Major Events Incentive Fund; Major Events Incentive Program
12	* * *
13	C. As used in this Section, the following terms have the following meanings:

15	(5) "Qualified major event" means a National Football League Super Bowl,
16	a National Collegiate Athletic Association Final Four tournament game, the National
17	Basketball Association All-Star Game, the X Games, a National Collegiate Athletic

8	E. The secretary of the Louisiana Economic Development is hereby
9	authorized to enter into a contract with an event producer or host, a local organizing
10	committee, endorsing parish, endorsing municipality, official tourism commission,
11	convention and visitors bureau, or official destination marketing organization to
12	recruit, solicit, acquire, or organize for Louisiana any qualified major event that will
13	have a significant positive impact in the state. Any contract entered into pursuant
14	to the provisions of this Subsection shall have the prior approval of the Joint
15	Legislative Committee on the Budget and be subject to the availability of
16	funding for such contract within the Major Events Incentive Fund. The contract
17	shall provide for a financial commitment to the entity. which shall not exceed the
18	amount to recruit, solicit, or acquire a major event or the qualified major
19	event's projected economic impact in the state, as demonstrated by an economic
20	impact analysis conducted by an economist selected by Louisiana Economic
21	Development, whichever is greater.
22	F. Upon completion of the qualified major event, the applicant shall
23	make all records related to the costs associated with attracting and hosting the
24	<u>qualified major event available for inspection by Louisiana Economic</u>
25	Development, and an economist selected by Louisiana Economic Development
26	shall prepare an economic impact analysis report which shall be paid for by the
27	entity contracting with Louisiana Economic Development as provided in
28	Subsection E of this Section. Any economic impact analysis provided in this
29	Section shall be submitted to the secretary of Louisiana Economic Development.

1	F. G. Any grants received pursuant to this Section may be used for either of
2	the following:

4	G.H. Louisiana Economic Development shall promulgate rules for the
5	administration of the program in accordance with the Administrative Procedure Act.
6	In order to expedite implementation of the program, the department shall utilize
7	emergency rulemaking for the promulgation of the initial administrative rules.

9	§1261. Events Incentive Fund
10	A.(1) There is hereby created in the state treasury, as a special fund, the
11	Events Incentive Fund, hereinafter referred to in this Section as the "fund".
12	(2) The source of monies deposited into the fund shall be any monies
13	appropriated by the legislature, including federal funds, any public or private
14	donations, gifts, or grants from individuals, corporations, nonprofit
15	organizations, or other business entities which may be made to the fund, and
16	any other monies which may be provided by law.
17	(3) Monies in the fund shall be invested in the same manner as monies
18	in the state general fund and any interest earned on the investment of monies
19	in the fund shall be credited to the fund. All unexpended and unencumbered
20	monies in the fund at the end of the fiscal year shall remain in the fund.
21	(4) Monies in the fund shall be used solely for attracting, planning,
22	marketing, and conducting events pursuant to the Events Incentive Program as
23	provided in this Section.
24	B. There is hereby created the Events Incentive Program, hereinafter
25	referred to in this Section as the "program", to be administered by Louisiana
26	Economic Development in accordance with rules and regulations. The program
27	shall provide grant funding to municipalities, parishes, official tourism
28	commissions, convention and visitors bureaus, official destination marketing
29	organizations, and nonprofit corporations hosting an event for costs associated

1	with planning, marketing, and conducting events held in Louisiana.
2	C. An entity shall be eligible to receive funding through the program
3	only if all of the following apply:
4	(1) The event is not a "qualified major event" as defined in R.S. 51:1260.
5	(2) The event is not held more than one time per year in Louisiana or any
6	other state. The provisions of this Paragraph shall not apply to events occurring
7	<u>twice in one year due to a natural disaster, an act of God, force majeure, a</u>
8	catastrophe, pandemic, or such other occurrence which causes the event to
9	move or be rescheduled.
10	(3) The applicant submits the application and required documentation
11	no later than one hundred eighty days prior to the event. The documentation
12	shall include:
13	(a) The total anticipated cost of the event.
14	(b) The amount and anticipated sources of funding for the event.
15	(c) An economic impact analysis conducted by an economist selected by
16	Louisiana Economic Development indicating the event has an anticipated
17	impact of three hundred fifty thousand dollars or greater to the state.
18	(d) A proposal for the utilization of the grant funding.
19	D. A municipality, parish, or nonprofit corporation hosting the event
20	shall be eligible to receive up to twenty-five percent of the total anticipated cost
21	incurred by the entity for the event, not to exceed two hundred fifty thousand
22	dollars per grant.
23	E. Any grants received pursuant to this Section may be used for either
24	of the following:
25	(1) To pay or reimburse the costs of applying or bidding for selection as
26	the site of the event.
27	(2) To pay or reimburse the costs of planning, marketing, or conducting
28	<u>the event.</u>
29	F. The secretary of Louisiana Economic Development shall select grant

1	recipients and is hereby authorized to enter into a contract with an event
2	producer or host, a local organizing committee, endorsing parish, endorsing
3	municipality, official tourism commission, convention and visitors bureau, or
4	official destination marketing organization to provide grant funding in
5	accordance with the provisions of Subsection E of this Section.
6	G. No later than September first of each year, the secretary of Louisiana
7	Economic Development shall submit an annual report on the program to the
8	Joint Legislative Committee on the Budget. The report shall include the entities
9	that received grant funding for events in the previous fiscal year pursuant to
10	this Section and the economic impact of the events to the state, to the extent
11	possible.
12	H. Louisiana Economic Development shall promulgate rules for the
13	administration of the program in accordance with the Administrative
14	Procedure Act.
15	Section 2. The provisions of this Act shall become effective on July 1, 2025.

<u>Present law</u> creates the Major Events Incentive Program to provide funding for specific qualifying major events in the state of La. <u>Present law</u> further creates the Major Events Incentive Fund as a source of funding for the program.

Proposed law retains present law.

<u>Present law</u> defines a "qualified major event" as being from a list of specific events provided in <u>present law</u>. <u>Proposed law</u> retains the list of specific events, but adds the following:

- (1) Events sanctioned by the Association of Tennis Professionals or Women's Tennis Association, including events on the ATP Tour or WTA Tour.
- (2) Events sanctioned by Professional Rodeo Cowboys Association, Professional Bull Riders, or any international amateur or professional rodeo or bull riding event.

<u>Present law</u> authorizes the secretary of LED to enter into contracts for qualified events that have significant positive impact to the state. <u>Proposed law</u> further requires any contract entered into for a qualified major event have prior JLCB approval and be subject to sufficient funding from the Major Events Incentive Fund.

<u>Proposed law</u> caps the amount eligible to be received for a qualified major event at the greater of the amount needed to solicit or attract an event or its projected economic impact in the state.

<u>Proposed law</u> requires an economic impact analysis to be completed by an economist selected by LED and submitted to the secretary of LED.

<u>Proposed law</u> creates the Events Incentive Program to provide grant funding to municipalities, parishes, official tourism commissions, convention and visitors bureaus, official destination marketing organizations, and nonprofit corporations hosting an event.

Proposed law requires LED to administer the program.

<u>Proposed law</u> provides for eligibility criteria and required documentation for events to receive funding through the program.

<u>Proposed law</u> requires any application and documentation required by <u>proposed law</u> to be submitted no later than 180 days prior to the event to be considered.

<u>Proposed law</u> provides that an entity is eligible to receive up to 25% of the total cost incurred by the entity for the event, not to exceed \$250,000 per event.

<u>Proposed law</u> authorizes the secretary of LED to enter into contracts with municipalities, parishes, official tourism commissions, convention and visitors bureaus, official destination marketing organizations, and nonprofit corporations for the purposes of distributing grant funding.

Proposed law requires LED to promulgate rules to administer the Events Incentive Program.

Effective July 1, 2025.

(Amends R.S. 51:1260(C)(5) and (6), (E), (F), and (G); adds R.S. 51:1260(H) and 1261)

Summary of Amendments Adopted by Senate

Committee Amendments Proposed by Senate Committee on Finance to the original <u>bill</u>

- 1. Restore the list of specific major events that are included in the definition "qualified major event" that as it is defined by <u>present law</u>.
- 2. Add events sanctioned by the Association of Tennis Professionals, Women's Tennis Association, Professional Rodeo Cowboys Association, Professional Bull Riders Association, or related events to the list of qualified major events.
- 3. Remove the definition of "significant positive impact"
- 4. Require JLCB approval and sufficient funding within the Major Events Incentive Fund for LED to enter into contracts providing funding for major events
- 5. Require the qualified major event to make all records related to the cost of the event available to LED and to complete an economic impact analysis for submission to the secretary of LED.
- 6. Create the Events Incentive Fund for the purpose of attracting, planning,

marketing, and conducting events pursuant to the Events Incentive Program.

- 7. Create the Events Incentive Program, administered by LED, to provide grants of 25% of an event's cost up to \$250,000 to applicants who are awarded grant funding.
- 8. Provide a procedure for qualification and application to the Events Incentive Program and required documentation necessary to qualify.
- 9. Require annual reporting of entities awarded grants from the Events Incentive Program to JLCB.
- 10. Require LED to promulgate rules for the administration of the program.
