30 D.(1) In addition to the penalties imposed pursuant to this Section, upon  
31 violation the offender shall be fined an additional five dollars.

32 (2) Monies collected pursuant to this Subsection shall be forwarded by the  
33 clerk of court to the state treasurer within thirty days of collection.

34 (3) After allocation to the Bond Security and Redemption Fund as provided  
35 in Article VII, Section (9)(B) of the Constitution of Louisiana, the state treasurer  
36 shall deposit the collections into the Louisiana Emergency Response Network Fund  
37 as established in R.S. 40:2845.
