Requires insurance coverage of home visiting services for newborns and young children

Proposed law requires coverage for home visiting services for newborns and young children. Home visiting services are evidence-based deliveries of services to families of newborns or families expecting newborns. Beginning from the 28th week of pregnancy to six weeks after birth, and continuing up to two to five years old. Coverage must include at least one visit during a newborn's first three months of life, with the opportunity for the family to choose follow-up visits. Coverage may be subject to annual deductibles, co-insurance, and copayment provisions established under the coverage plan, and may be subject to a limit per pregnancy or childbirth of not less than \$1,500.
