It shall be unlawful for any person who is placed on electronic 14 15 monitoring supervision pursuant to this Part, or any other provision of law, to intentionally do any of the following: 16 (1) Enter an exclusion zone. 17 18 (2) Fail to immediately exit an exclusion zone. 19 (3) Violate a curfew order. 20 B.(1) Whoever violates Subsection A of this Section shall be fined not 21 more than five hundred dollars, imprisoned for not more than six months, or 22 both. 23 (2) Whoever commits a felony while violating Subsection A of this 24 Section shall be fined not more than one thousand dollars and shall be 25 imprisoned, at hard labor, for one year. 26 (3) Whoever violates Subsection A of this Section, after being released on bail for a felony crime of violence as defined by R.S. 14:2(B), shall be fined 27 28 not more than one thousand dollars and shall be imprisoned, at hard labor, for 29 one year. 30 C. As used in this Section: 31 (1) "Curfew" means a specified time period defined by court order 32 during which a person is required to either be, or not be, in a specific location. (2) "Exclusion zone" means a specified geographic area defined by court 33 34 order that a person is prohibited from entering or remaining.
- 35 (3) "Inclusion zone" means a specified geographic area defined by court
 36 order in which a person is either allowed or required to be."
