The governor shall designate the Governor's Office of Homeland 15 Security and Emergency Preparedness within the Military Department as the state homeland security and emergency preparedness agency. The office shall be an 16 17 independent agency in the office of the governor and, through its director, shall report directly to the governor. The office shall have authority for and shall be 18 19 responsible for its own accounting and budget control, procurement and contract 20 management, personnel management, and grants management and shall carry out 21 these functions either directly or through authorized assignment to another state agency or department. The office through the Military Department, which shall have 22 23 authority to enter into contracts and agreements necessary in carrying out it's the 24 office's functions and responsibilities."

31 "H. The director, subject to the direction and control of the governor, acting 32 through the adjutant general, shall be the executive head of the state homeland 33 security and emergency preparedness agency and as such shall be responsible to the 34 governor for carrying out the programs for homeland security and emergency 35 preparedness for the state of Louisiana. For actions related to a gubernatorially declared disaster or emergency, the agency and director shall report to the governor 36 or a person designated by the governor for that purpose. He shall coordinate the 37 38 activities of all agencies and organizations for homeland security and emergency 39 preparedness within the state and shall maintain liaison with and cooperate with 40 homeland security and emergency preparedness agencies and organizations of other

1 states and of the federal government. He shall coordinate public-private sector 2 relationships in order to meet the needs of an emergency or disaster pursuant to R.S. 3 29:726. All state agencies and departments shall comply with directives from the 4 Governor's Office of Homeland Security and Emergency Preparedness relating to 5 emergency planning and operations. He shall coordinate the implementation of the Emergency Management Assistance Compact pursuant to R.S. 29:733. The 6 provisions of this Subsection shall not supersede the powers, duties, or authority of 7 8 the Department of Public Safety and Corrections, office of state police. 9 *" * *
