All testing that is provided by a healthcare provider pursuant to the 15 provisions of this Section shall be considered a medically necessary covered service by 16 any health insurance issuer as defined in R.S. 22:1005 and by any managed care 17 organization as defined in R.S. 46:460.51(9). In addition, health insurance issuers and 18 managed care organizations shall be prohibited from requiring prior authorization or 19 imposing any utilization management requirements as a condition of payment for any 20 testing provided pursuant to the provisions of this Section. 21 * * *

§1123.5. Prenatal screening for substance use disorder

23 A. Every licensed healthcare provider who provides prenatal care to a pregnant 24 woman shall screen her for substance use disorder during the first trimester of 25 pregnancy or at the time of first examination after confirming pregnancy, if the 26 provider utilizing his professional medical judgment believes that the screening would 27 be in the best interest of the patient and such screening has not already occurred. The 28 healthcare provider providing such screening shall utilize a validated verbal screening 29 tool for substance use disorder that aligns with standards of the American College of 30 Obstetricians and Gynecologists. The Louisiana Department of Health, office of public 31 health shall post a list of approved validated verbal screening tools on its website. For 32 purposes of this Section, "licensed healthcare provider" means a physician, advanced 33 practice registered nurse, or physician assistant. 34 B. After administering the screening provided for in Subsection A of this

35 Section, a licensed healthcare provider who determines that a pregnant woman is at
 36 risk for substance use disorder shall refer the woman for appropriate treatment.
