21 §236.1. Approval of home study programs

23 H.(1) Two or more parents whose children are participating in an approved  
24 home study program may form a home study education cooperative for any of the  
25 following purposes:

26 (a) Increasing a child's academic performance.

27 (b) Completing courses required for a Taylor Opportunity Program for a  
28 student scholarship pursuant to R.S. 17:5001et seq..

29 (c) Facilitating socialization for student enrichment.

30 (d) Facilitating student recreational or athletic activities.

31 (2) For purposes of this Subsection, "home study education cooperative"  
32 means one or more parents whose children are participating in an approved home

1 study program and the children meet in a parent's home, community center, church,  
2 or place of worship to collectively study a curriculum chosen by the participating  
3 families.

5 §407.33. Definitions

6 As used in this Part, the following terms have the following meanings unless  
7 the context clearly indicates otherwise:

8 (1) "Camp" means any place or facility operated by any institution, society,  
9 agency, corporation, person or persons, or any other group which serves only  
10 children five years of age or older and operates only when school is not in session  
11 during the summer months or school holidays including, but not limited to, a  
12 Vacation Bible School, or Bible Camp.

14 (9) "Mother's day out program" means a religious enrichment program for  
15 children offered at a church or other place of worship that meets the requirements of  
16 R.S. 17:407.35(B)."
