Provides relative to the office of the state public defender

<u>Current law</u> provides for the powers and duties of district public defenders; provides for the authority of the Office of the State Public Defender (OSPD) to take disciplinary actions against district defenders; provides for hearings and investigations by the board to determine the reasonableness of actions to terminate district defenders; provides for the duties of the Oversight Board relative to administration of hearings and investigations; provides for proceedings to determine indigency. <u>Proposed law</u> provides that the board members of the OSPD may attend and conduct board meetings via electronic means no more than twice per calendar year; provides that a district defender who contracts with the OSPD is an independent contractor and not an agent of the OSPD; provides that the right to a hearing and investigation regarding the demotion or termination of a district defender is limited to instances of discipline or early contract termination, and that a district defender has no right to a hearing for non-renewal of a contract; provides that the OSPD has the sole authority to contract for legal service delivery; provides that the chairman of the Oversight Board shall appoint a hearing committee to enforce provisions regarding the appropriateness of termination for just cause; provides that no clerk of court shall charge or collect fees for the filing of a writ application for an appeal when a determination has been made that the applicant or appellant is indigent.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The Office of the State Public Defender has advised that there is no projected fiscal impact with the enactment of the proposed law.

REVENUE EXPLANATION

<u>Proposed law may result in an indeterminable decrease in Local revenues to the five circuit courts of appeal, to the extent that clerks of court are prohibited from charging or collecting any fees for the filing of a writ application or an appeal when a determination has been made that the applicant or appellant is indigent. The filing fees for writ applications for appeals range from \$181 per writ application to \$331 per writ application. The exact fiscal impact to circuit courts of appeal is indeterminable, as it is unknown the number of indigent appellants that will submit writ applications for appeals after a determination is made concerning indigency in the future.</u>

Note: The LFO is working with the clerks of court of the five circuit courts of appeal to retrieve past statistical information regarding the number of writ applications that they have received from indigent appellants, and this information will be provided as it becomes available.
