2	To amend and reenact R.S. 4:61(A), 65(A)(2) and (B), 67(C)(1), 72, 79(C), 81.1(A),	
3	83(B)(2) and (C)(1), and 85(3) and R.S. 36:4.1(C)(11) and to enact R.S. 4:67(C)(4),	
4	relative to the State Boxing and Wrestling Commission; to change the name of the	
5	commission; to provide with respect to a safety zone for events; to provide for the	
6	assessment of fees; to provide that the board shall not receive any state funds; to	
7	repeal provisions regarding salaries for board members; to repeal the statutorily	
8	defined amounts of certain licensing fees; to authorize the board to fix salaries and	
9	licensing fees; to provide with respect to an events coordinator; to provide with	
10	respect to the venue capacity for certain professional wrestling events; to provide for	
11	professional wrestling event fees; to provide for an exception for profession	
12	wrestling bonds; and to provide for related matters.	
13	Be it enacted by the Legislature of Louisiana:	
14	Section 1. R.S. 4:61(A), 65(A)(2) and (B), 67(C)(1), 72, 79(C), 81.1(A), 83(B)(2)	
15	and (C)(1), and 85(3) are hereby amended and reenacted and R.S. 4:67(C)(4) is hereby	
16	enacted to read as follows:	
17	§61. State Boxing and Wrestling Louisiana State Athletic Commission; domicile;	
18	authority	
19	A. There is hereby created a State Boxing and Wrestling Louisiana State	
20	Athletic Commission within the office of the governor. It shall consist of seven

1	members, all of whom shall be appointed by the governor to serve at the pleasure of		
2	the governor making the appointment. Five members appointed by the governor		
3	shall be appointed, one from each Public Service Commission district and two from		
4	the state at large. Each appointment by the governor shall be submitted to the Senate		
5	for confirmation. The governor shall designate one member as chairman, one		
6	member as secretary, and one member as vice chairman. The secretary shall execute		
7	a bond of five thousand dollars, in favor of the state treasurer, for the faithful		
8	performance of the duties of his office. The premium of this bond shall be paid out		
9	of the commission funds.

14	(2) Before any such license is granted, the applicant shall execute and file		
15	with the State Boxing and Wrestling Louisiana State Athletic Commission a bond		
16	of five thousand dollars in favor of the Louisiana State Boxing and Wrestling		
17	Athletic Commission as a security of good faith and ability to abide by the terms and		
18	provisions of this Chapter, for which the commission secretary shall issue to the		
19	applicant a certificate of its filing and approval. In lieu thereof, a certified check will		
20	be acceptable, which amount shall be kept on deposit by the secretary for the		
21	duration of the license period. This bond may be increased by the commission		
22	before approving the holding, conducting, or giving of any boxing, mixed technique		
23	event, or wrestling exhibition or contest, based upon the seating capacity of the hall		
24	or facility where said contest or exhibition is to be conducted. The following		
25	schedule shall govern the amount of the additional bond that may be required to be		
26	posted with the commission for the holding, conducting, or giving of a boxing,		
27	mixed technique event, or wrestling contest or exhibition:

15	C.(1) The taxes provided for by this Section shall constitute a special fund,		
16	which shall be disbursed as provided in this Chapter. The commission shall receive		
17	the following salaries: the chairman shall receive a salary of ten thousand dollars per		
18	annum; the vice chairman shall receive a salary of six thousand four hundred dollars		
19	per annum; the secretary shall receive a salary of seven thousand two hundred dollars		
20	per annum; the four other members of the commission each shall receive a salary of		
21	four six thousand three hundred dollars per annum, said all salaries to be paid from		
22	the monies available in the special fund. If the money available in the special fund		
23	is insufficient to pay the maximum salaries herein authorized, such salaries shall be		
24	reduced proportionately and paid in such amounts as will not exceed the funds		
25	available in the special fund. Notwithstanding any other provision of this Section,		
26	any commissioner who is required to travel to attend, organize, or oversee any		
27	boxing event, mixed technique event, or wrestling event shall be entitled to the		

1	payment of a per diem of eighty dollars per day, such amount being immediately due		
2	and payable to the commission member at the time of the given event.

4	(4) Each member of the commission shall receive a per diem, in an amount		
5	set by the commission, not to exceed one hundred fifty dollars per day, for		
6	attendance at commission meetings or other official commission-approved business		
7	or activities, not to exceed ten days in any one month. Each member shall be		
8	reimbursed actual expenses reasonably necessary for attending commission or		
9	committee meetings or for representing the commission or participating in an official		
10	commission-approved activity.

12	§72. Proximity of seats to ring; seating for the commission Safety Zone		
13	There shall be no seats, except those provided for the press and timers,		
14	physicians, and commissioners, within four feet of the sides of the ring, or within six		
15	feet of the corners of the ring, except those approved by the commission. The club		
16	shall, without charge, provide seating for the commission as is necessary for the		
17	attendance of the commission and those persons necessary to work the event.		
18	A. At each event, there shall be an area around the ring or cage extending no		
19	less than eight feet as measured from the ring, cage, or from the catwalk which shall		
20	be partitioned at that distance of eight feet using ropes, fencing, police barriers,		
21	bicycle barriers, or other emplacements from the public seating and that area shall		
22	be referred to as the "safety zone".		
23	B. All of the following shall apply to the safety zone:		
24	(1) No one may enter the safety zone unless authorized by the commission.		
25	(2) All seating inside of the safety zone shall be authorized only by the		
26	commission in attendance.		
27	(3) Anyone entering the safety zone without the authority of the commission		
28	may be ejected from the event.

8	§81.1. Tough-man contest; prohibition
9	A. For the purposes of this Chapter, "tough-man contest" shall mean any
10	boxing match, wrestling event, or competition, or combination thereof, between two
11	or more persons, whether professional or amateur, who use their hands, with or
12	without gloves, or their feet, or both, in any manner unauthorized by the State
13	Boxing and Wrestling Louisiana State Athletic Commission, and compete for
14	money, financial prize, or any item of pecuniary or nonpecuniary value or compete
15	at an event where a fee is charged whereby either participant may obtain pecuniary
16	gain. The term "tough-man contest" shall not include, nor shall the provisions of this
17	Section apply to any contest, competition, or exhibition of any of the recognized
18	martial arts including karate, judo, kung fu, tae kwan do, jujitsu, kickboxing, or any
19	substantially similar tradition.

Abstract: Provides for changes to the State Boxing and Wrestling Commission.

<u>Present law</u> provides that the State Boxing and Wrestling Commission (commission) has authority to regulate boxing and wrestling contests.

<u>Proposed law</u> changes the name of the commission to the Louisiana State Athletic Commission and otherwise retains <u>present law</u>.

<u>Present law</u> establishes fixed salaries for members of the commission and commission employees.

<u>Proposed law</u> changes the salaries of some members of the commission.

Present law establishes fixed fees for various license types issued by the commission.

Proposed law increases the fees for those licenses.

<u>Proposed law</u> creates a safety zone for events which <u>proposed law</u> defines as an area around the ring or cage extending no less than eight feet as measured from the ring, cage, or from the catwalk which shall be partitioned at that distance of eight feet using ropes, fencing, police barriers, bicycle barriers, or other emplacements from the public seating.

<u>Proposed law</u> further provides that no one not specifically authorized by commission members in attendance may sit in the safety zone and non-compliance can result in a person being ejected from the event.

The <u>proposed law</u> safety zone replaces the <u>present law</u> provisions regarding seat proximity to the ring.

<u>Present law</u> provides a per diem to be paid to commission members to oversee or attend boxing, wrestling, or mixed technique events.

<u>Proposed law</u> repeals per diem provisions of <u>present law</u> and provides for per diem, not to exceed \$150, to be paid to commission members for attendance at commission meetings and activities.

<u>Present law</u> provides that the commission may appoint an events coordinator, not on the commission, for any boxing event the commission deems necessary, whose fee shall be paid by the club promoting the event in question, which amount shall not exceed \$350 per event.

<u>Proposed law</u> removes prohibition that the events coordinator cannot be on the commission and removes the \$350 amount of the fee and allows the fee to be set by commission.

<u>Proposed law</u> changes the name of the State Boxing and Wrestling Commission to the Louisiana State Athletic Commission in applicable <u>present law</u>.
