24	Criminal Identification and Information of the office of state police within the
25	Department of Public Safety and Corrections shall survey its criminal history records
26	and identification files and make a simultaneous request of the Federal Bureau of
27	Investigation for like information from other jurisdictions. The Louisiana Bureau of
28	Criminal Identification and Information of the office of state police within the
29	Department of Public Safety and Corrections may charge the board a reasonable
30	processing fee for conducting and reporting on any such search.
