"(3)(a) Subject to the limitation provided in Subparagraph (b) of this 18 19 Paragraph, beginning July 1, 2027, and each July first thereafter, if the sum of the actual premium tax and retaliatory tax collections for the preceding taxable period 20 21 exceeds two hundred sixty-eight million dollars, the insurance premium tax rate provided for in this Section for the current taxable period shall be reduced by an 22 23 amount equal to two tenths of one percent. The reduced rate shall be effective January first of the current taxable period. When the provisions of this Paragraph 24 25 require a reduction in the insurance premium tax rate, the commissioner of insurance 26 shall publish notice of the reduced rate on the Department of Insurance website.

- (b) If the insurance premium tax rate is reduced to one percent, there shall
   be no further reductions to the rate."
