11 On page 1, line 9, after "to" and before "the penalties" delete "provide for clarifying" and

29 On page 5, line 6, after "**inch**" and before "**lettering**" change "**white**" to "**black**"

2 On page 5, line 9, after "inch" and before "lettering" change "white" to "black"

3 AMENDMENT NO. 14

4 On page 5, delete lines 27 through 29 in their entirety

5 AMENDMENT NO. 15

6 On page 6, delete line 1 in its entirety and insert a set of asterisks "\* \* \*"

7 AMENDMENT NO. 16

8 On page 6, between lines 15 and 16, insert the following:

9 "(10) Each mailed citation shall include a self-addressed stamped  
10 envelope, a Quick Response code, or other internet link to a portal that provides  
11 vehicle owners access to the certification referenced in Subparagraph (4)(e) of  
12 this Subsection without a fee."
