15 The Legislature of Louisiana does hereby find that pursuant to the Tenth
16 Amendment of the Constitution of the United States and the inherent right of
17 Louisiana citizens to engage in thoughtful deliberation and to determine public
18 policy by voting, the citizens of Louisiana do not consent to unconstitutional actions
19 or efforts made by the federal government or international bodies that release
20 contaminants into Louisiana's atmosphere through geoengineering, solar radiation
21 modification, cloud seeding, weather modification, or any other means."

7 emission of air pollutants which are incidental to and not the primary purpose of
8 operating a source.

9 B.(1) Any person who observes an activity which may be conducted in
10 violation of Subsection A of this Section may report the observed activity to the
11 Department of Environmental Quality.

12 (2) The department shall establish procedures for intake of reports made
13 pursuant to this Subsection, which shall include provisions for electronic submittal.

14 (3) The department shall receive the reports for the purposes of data
15 collection and shall make the reports publicly available through the department's
16 website or the Electronic Document Management System."
