INSURANCE/HEALTH: Requires health insurance coverage for integrative cancer treatments

1	AN ACT
2	To enact R.S. 22:1077.4, relative to integrative treatments for cancer; to require health
3	insurance coverage for such treatments; to require coverage for Medicare enrollees;
4	to provide for definitions; to provide for applicability and effectiveness; and to
5	provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 22:1077.4 is hereby enacted to read as follows:
8	§1077.4. Required coverage for integrative cancer treatments; acupuncture; cooling
9	systems; cryotherapy
10	A. A health insurance issuer offering health coverage plans in this state that
11	provide hospital, medical, or surgical benefits for individuals covered under a
12	respective plan shall provide coverage for integrative cancer treatments, including
13	acupuncture, cryotherapy, and scalp cooling systems used in connection with
14	medical treatment for cancer when such treatments are recommended by nationally
15	recognized cancer treatment guidelines. Coverage provided pursuant to this Section
16	may be subject to annual deductibles, coinsurance, and copayments consistent with
17	those established under the health coverage plan. The provisions of this Section
18	apply to individuals eligible for Medicare coverage.

1	B. For the purposes of this Section, "scalp cooling system" means any device
2	used to cool the human scalp to prevent or reduce hair loss during chemotherapy
3	treatment for cancer, provided that such device is designed and intended for repeated
4	use and is primarily and customarily used to serve a medical purpose.
5	Section 2. The provisions of this Act apply to any new policy, contract, or health
6	coverage plan issued on and after January 1, 2026. Any policy, contract, or health coverage
7	plan in effect prior to January 1, 2026, shall convert to conform to the provisions of this Act
8	on or before the renewal date, but no later than January 1, 2027.
9	Section 3. This Act shall become effective on January 1, 2026.

Abstract: Requires health insurers, including Medicare provider organizations, to cover integrative cancer treatments in combination with medical treatment for cancer.

<u>Proposed law</u> requires a health insurance issuer offering health coverage plans in the state of La. that provide hospital, medical, or surgical benefits to cover integrative cancer treatments, including acupuncture, scalp cooling systems, and cryotherapy when such treatments are combined with medical treatment for cancer and are recommended by nationally recognized cancer treatment guidelines. Applies to treatments for persons eligible for Medicare coverage.

<u>Proposed law</u> authorizes health coverage plans to apply annual deductibles, coinsurance, and copayments established under the plan.

<u>Proposed law</u> applies to any new policy, contract, or plan issued on and after Jan. 1, 2026. Requires any policy, contract, or plan in effect prior to Jan. 1, 2026, to convert to conform to <u>proposed law</u> on or before the renewal date, but no later than Jan. 1, 2027.

Effective January 1, 2026.

Summary of Amendments Adopted by House

- The Committee Amendments Proposed by <u>House Committee on Insurance</u> to the <u>original</u> bill:
- 1. Require covered treatments to be recommended by nationally recognized cancer treatment guidelines.
- 2. Remove application to Medicaid enrollees.

- 3. Apply <u>proposed law</u> to any new policy, contract, or plan issued on and after Jan. 1, 2026, and require existing policies to conform with <u>proposed law</u> by Jan. 1, 2027.
- The Committee Amendments Proposed by <u>House Committee on Appropriations</u> to the <u>engrossed</u> bill:
- 1. Remove required coverage for dental services.
