SENATE RESOLUTION NO. 126

HEALTH DEPARTMENT. Requests the Louisiana Department of Health to post nursing home ratings on its website.

1	A RESOLUTION
2	To urge and request the Louisiana Department of Health to post the Five-Star Quality Rating
3	for each Louisiana nursing home on its website.
4	WHEREAS, the decision to place a loved one in a nursing home is a somber
5	realization that a person can no longer care for themselves; and
6	WHEREAS, selecting the right nursing facility can be an overwhelming process that
7	leaves family members with conflicting emotions of doing the right thing to ensure proper
8	care and the feeling of helplessness that comes with relinquishing that responsibility to
9	someone else; and
10	WHEREAS, the quality of nursing facilities can vary significantly and it is important
11	that the public is aware of any issues with a facility before entrusting it to care for a member
12	of the incredibly vulnerable elderly population; and
13	WHEREAS, family members need access to reliable data in selecting the nursing
14	home that is best for their loved one; and
15	WHEREAS, an invaluable piece of data is the Centers for Medicare and Medicaid
16	Services' Five-Star Quality Rating System; and
17	WHEREAS, the Five-Star Quality Rating System reflects a nursing home's rating for
18	health inspections, quality measures, and staffing, factors that are all critically important in

1	selecting a nursing home for a loved one; and
2	WHEREAS, the Louisiana Department of Health's website currently includes a
3	nursing home locator feature; and
4	WHEREAS, prominently displaying a nursing home's current Five-Star Quality
5	Rating next to the facility's name on the website would allow families easy access to that
6	critical information; and
7	WHEREAS, access to the Five-Star Quality Rating will help families make better
8	choices for the long-term care of their loved ones and encourage nursing homes to strive to
9	maintain their high scores or to improve their scores.
10	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
11	does hereby urge and request the Louisiana Department of Health to post the Five-Star
12	Quality Rating for each Louisiana nursing home on its website.
13	BE IT FURTHER RESOLVES that a copy of this Resolution be transmitted to the
14	secretary of the Louisiana Department of Health.
