

HOUSE COMMITTEE AMENDMENTS

2025 Regular Session

Amendments proposed by House Committee on Administration of Criminal Justice to Reengrossed Senate Bill No. 87 by Senator Barrow

1 AMENDMENT NO. 1

2 On page 1, line 2, after "Procedure" and before "relative" change "Art. 334," to "Articles  
3 326(B) and 330(A) through (C), (D)(introductory paragraph), and (E) and to enact Code of  
4 Criminal Procedure Article 326(F),"

5 AMENDMENT NO. 2

6 On page 1, delete lines 3 through 5 in their entirety and insert "relative to cash deposits; to  
7 provide relative to a cash depositor as a surety; to provide relative to notice; to provide  
8 relative to the appearance of the defendant in connection with a bail undertaking; and to  
9 provide for related matters."

10 AMENDMENT NO. 3

11 On page 1, line 7, after "Procedure" delete the remainder of the line and insert "Articles  
12 326(B) and 330(A) through (C), (D)(introductory paragraph), and (E) are hereby amended  
13 and reenacted and Code of Criminal Procedure Article 326(F) is hereby enacted to"

14 AMENDMENT NO. 4

15 On page 1, delete lines 9 through 17 in their entirety and delete page 2 in its entirety and  
16 insert the following:

17 "Art. 326. Cash deposits  
18 \* \* \*  
19 B. Upon final disposition of all cases in which a deposit of money, checks,  
20 bonds, or money orders has been made pursuant to this Article, and the deposits have  
21 remained unclaimed for a period of one year from the date of the final disposition,  
22 the officer authorized to accept the bail shall apply and use one-half of such funds  
23 for the operation and maintenance of the office of the clerk of court, or the office of  
24 the clerk of the criminal district court, or the office of the clerk of the criminal  
25 district court in Orleans Parish, and one-half to the local governing authority after  
26 advertising his intention to so utilize the funds by publication in the official parish  
27 journal of a notice to the public containing an itemized list of all of such funds on  
28 deposit, containing the names and last known addresses of defendants and the docket  
29 numbers of the cases involved. The publication shall be made once within thirty  
30 days after the final disposition of the case as aforesaid. The clerk shall also send a  
31 notice by certified mail to each of such defendants at the last known address of the  
32 defendant. **The clerk shall also send a notice by certified mail to any cash**  
33 **depositor, if any, provided that the clerk has received the information necessary**  
34 **for service.** Any interest earned on the funds deposited for bail shall be disbursed  
35 as provided in Paragraph E of this Article.

37 **F. For purposes of this Article, "cash depositor" means any entity who,**  
38 **on behalf of the defendant, furnishes a bail undertaking pursuant to Paragraph**  
39 **A of this Article in lieu of a surety. Nothing in this Article shall be construed to**  
40 **establish a cash depositor as a surety in a bail undertaking.**

42 Art. 330. Notice of defendant's required appearance  
43 A. When a bail undertaking fixes an appearance date, the defendant appears  
44 as ordered, and notice of the next appearance date is given to the defendant, no

1 additional notice of that appearance date is required to be given to the defendant, ~~or~~  
2 the personal surety, ~~or~~ the commercial surety, **the cash depositor**, or the agent or  
3 bondsman who posted the bail undertaking for the commercial surety.

4 B. When a bail undertaking does not fix the appearance date, written notice  
5 of the time, date, and place the defendant is first ordered by the court to appear shall  
6 be given to the defendant or his duly appointed agent and his personal surety, ~~or~~ the  
7 commercial surety, **the cash depositor**, or the agent or bondsman who posted the  
8 bail undertaking for the commercial surety.

9 C. If the defendant appears as ordered and the proceeding is continued to a  
10 specific date, the defendant and the personal surety, ~~or~~ the commercial surety, **the**  
11 **cash depositor**, or the agent or bondsman who posted the bail undertaking for the  
12 commercial surety and who has been given initial notice pursuant to Paragraph A or  
13 B of this Article, need not be given notice of the new appearance date. If the  
14 defendant fails to appear as ordered, or the proceeding is not continued to a specific  
15 date, the defendant or his duly appointed agent, the personal surety, **the cash**  
16 **depositor**, or the agent or bondsman who posted the bail undertaking for the  
17 commercial surety shall be given notice of the new appearance date.

18 D. Notice required pursuant to the provisions of this Article to the defendant  
19 and the personal surety, **the cash depositor**, ~~or~~ the commercial surety, or the agent  
20 or bondsman who posted the bail undertaking for the commercial surety shall be  
21 made to the address provided pursuant to Article 329. Notice may be:

23 E. Failure to give the notice required by this Article relieves the surety **and**  
24 **cash depositor** from liability on a judgment of bond forfeiture for the nonappearance  
25 of the defendant on that particular date.
