1 AMENDMENT NO. 1

2 On page 2, delete lines 22 and 23 and insert the following:

3 "(4) "Application" means a software program that is designed to run on a
4 connected device and to perform, or to help, the user perform a specific task on a
5 connected device.

6 (5) "Connected device" means a smartphone, tablet, computer, gaming
7 console, or virtual reality device that enables users to connect to the internet and
8 download software applications."

18 are reasonably designed to ensure accuracy, including but not limited to a means of
19 verification provided through the use of a real-time age verification system authorized by
20 the commissioner of the office of motor vehicles.

21 (b) For individuals under eighteen years of age, a method is commercially available
22 if it includes affirmative age attestation by someone who is reasonably believed to be the
23 parent or legal guardian, along with other information collected in the ordinary course of
24 account creation or use.

25 (3) If the age verification methods or process described in Paragraphs (1) and (2) of
26 this Subsection determines the individual to be a minor, the developer shall do both of the
27 following:

28 (a) Require the account to be affiliated with parent account.

29 (b) Obtain verifiable parental consent from the holder of the affiliated parent account
30 before allowing the minor to download an application, purchase an application, or make an
31 in-application purchase."

18 required by law. A developer shall not rely on age category obtained under this Part to the
19 extent those signals satisfy the requirements of applicable law."

23 On page 10, delete lines 1 through 19 and insert the following:

24 "A. A violation of this Part shall be considered a false, misleading, or deceptive act
25 or practice.

26 B. In addition to any other remedy available under law, the attorney general may
27 bring a civil action to enforce any violation of this Part.

28 C. (1) A covered application store or developer that violations the provisions of this
29 Part shall be subject to a civil fine of up to ten thousand dollars per violation."
