COURTS: Continues and reestablishes the Judicial Security Task Force as established by House Concurrent Resolution No. 40 of the 2024 Regular Session

1	A CONCURRENT RESOLUTION
2	To continue and reestablish the work of the Judicial Security Task Force, to extend the
3	deadline for reporting its findings and recommendations to the House Committee on
4	Judiciary and the Senate Committee on Judiciary B no later than January 1, 2027.
5	WHEREAS, House Concurrent Resolution No. 40 of the 2024 Regular Session of
6	the Louisiana legislature created and established the Judicial Security Task Force; and
7	WHEREAS, the Judicial Security Task Force is continuing its invaluable research
8	and requires additional time to complete the report of its findings and recommendations.
9	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
10	continue and reestablish the Judicial Security Task Force to identify the minimum
11	requirements necessary for courthouse safety to ensure the protection, safety, and security
12	of judicial officers and their families.
13	BE IT FURTHER RESOLVED that the Judicial Security Task Force shall submit
14	a written report of its findings and recommendations to the House Committee on Judiciary
15	and the Senate Committee on Judiciary B no later than January 1, 2027.
16	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
17	governor, the chief justice of the supreme court, the chair of the Louisiana Conference of
18	Court of Appeals Judges, the president of the Louisiana District Judges Association, the
19	president of the Louisiana Council of Juvenile and Family Court Judges, the president of the
20	Louisiana City Court Judges Association, the superintendent of the Louisiana State Police,
21	the chairman of the House Committee on Judiciary, the president of the Senate, and the
