

HOUSE COMMITTEE AMENDMENTS

2025 Regular Session

Amendments proposed by House Committee on Commerce to Engrossed Senate Bill No. 37 by Senator Hensgens

1 AMENDMENT NO. 1

2 On page 1, delete lines 13 through 17 and insert in lieu thereof the following:

3 "(1) A chairman of the commission shall be appointed from the state at large.
4 Fourteen members shall be appointed in such manner that at least one shall be from each of
5 the commission districts as listed below:

6 (a) Commission District 1 shall consist of the following parishes: Orleans,
7 Plaquemines, St. Bernard, St. Tammany, and Washington.

8 (b) Commission District 2 shall consist of the following parishes: Jefferson, St.
9 Charles, St. John, St. James, and Tangipahoa.

10 (c) Commission District 3 shall consist of the following parishes: East Baton Rouge,
11 West Baton Rouge, Iberville, Ascension, East Feliciana, West Feliciana, St. Helena,
12 Livingston, Assumption, and Pointe Coupee.

13 (d) Commission District 4 shall consist of the following parishes: Richland,
14 Franklin, Union, Lincoln, Jackson, Winn, Caldwell, Ouachita, Morehouse, West Carroll,
15 East Carroll, and Madison.

16 (e) Commission District 5 shall consist of the following parishes: Caddo, Bossier,
17 Webster, DeSoto, Red River, Bienville, Claiborne, and Sabine.

18 (f) Commission District 6 shall consist of the following parishes: Rapides, Grant,
19 LaSalle, Catahoula, Concordia, Avoyelles, Vernon, Tensas, and Natchitoches.

20 (g) Commission District 7 shall consist of the following parishes: Beauregard, Allen,
21 Calcasieu, Cameron, Jefferson Davis, Acadia, and Evangeline.

22 (h) Commission District 8 shall consist of the following parishes: Lafayette, St.
23 Landry, St. Martin, St. Mary, Iberia, Terrebonne, Lafourche, and Vermilion."

25 On page 2, delete lines 1 through 16 in their entirety

27 On page 3, delete lines 22 through 26 in their entirety

28 AMENDMENT NO. 4

29 On page 4, line 17, after "**public,**" insert "**which shall constitute the dispute resolution**
30 **panel,**"

31 AMENDMENT NO. 5

32 On page 4, delete lines 23 through 29 in their entirety and insert in lieu thereof the following:

33 **"(4)(a) All persons or parties to a dispute have the right to have any**
34 **dispute, protest, complaint, or other contested matter heard and determined by**
35 **the dispute resolution panel.**

36 **(b)(i) The dispute resolution panel shall exclusively exercise the**
37 **adjudicatory authority of the commission, including the power to issue**
38 **subpoenas, compel the attendance of witnesses, administer oaths, and receive**
39 **evidence in connection with any hearing or other proceeding within its**
40 **jurisdiction and render final decisions. This authority includes the power to**
41 **order remedies and impose fines as authorized by this Chapter and Chapter 6-A**

1 of this Title of the Louisiana Revised Statutes, and Chapter 10-B of Title 6 of the
2 Louisiana Revised Statutes.

3 (ii) In the exercise of its investigatory function, the executive director
4 may issue subpoenas, compel the attendance of witnesses, administer oaths, and
5 receive evidence.

6 (c) The jurisdiction of the dispute resolution panel shall include all
7 disputes, protests, complaints, or other contested matters involving licensees of
8 the commission or involving licencees of the commission and matters involving
9 any person or entity operating without a required license, including those
10 subject to licensure pursuant to this Chapter and Chapter 6-A of this Title of
11 the Louisiana Revised Statutes and Chapter 10-B of Title 6 of the Louisiana
12 Revised Statutes. The members of the dispute resolution panel shall not
13 participate in nor vote on any of the other business of the commission.

14 (d) Nothing in this Paragraph shall preclude the commission from
15 offering informal dispute resolution procedures prior to formal adjudication
16 hearings, but no party shall be compelled to participate in informal resolution
17 in lieu of a hearing before the dispute resolution panel.

18 (e) The dispute resolution panel shall elect a chair to serve as the
19 presiding officer for each proceeding. The commission staff shall exercise the
20 investigatory authority of the commission as delegated and subject to oversight
21 by the commission."

11 appointment of the Louisiana Supreme Court, together with any expenses in an amount
12 fixed by the commission and authorized by law"
