Creates the Louisiana Roof Registry

Proposed law creates the Louisiana Roof Registry under the Louisiana Department of Insurance (LDI). The Louisiana Roof Registry is a voluntary registry that allows property owners and local and municipal governments that require building permits to submit information related to those permits.

**EXPENDITURE EXPLANATION**

Proposed law is anticipated to result in a one-time IT cost of \$45,430 in Self-Generated expenditures to set up a database for a Louisiana Roof Registry in FY 26. This registry allows property owners and local municipal governments that require building permits to voluntarily submit information related to those permits.

LDI reports the IT costs to develop the online portal will be performed by an applications development contractor through a professional services contract (413 hours X \$110 blended average rate = \$45,430). LDI reports that the projected costs associated with the proposed law will be performed using existing Self-Generated revenues appropriated within the LDI budget.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
