1 AMENDMENT NO. 1

2 On page 1, delete lines 12 through 15 in their entirety

3 AMENDMENT NO. 2

4 On page 1, line 16, delete "(C)" and insert "(B)"

5 AMENDMENT NO. 3

6 On page 1, line 19, delete "(D)" and insert "(C)"

7 AMENDMENT NO. 4

8 On page 2, line 1, delete "(E)" and insert "(D)"

9 AMENDMENT NO. 5

10 On page 2, line 4, delete "(F)" and insert "(E)"

11 AMENDMENT NO. 6

12 On page 2, line 7, delete "(G)" and insert "(F)"

13 AMENDMENT NO. 7

14 On page 2, between lines 9 and 10 insert the following:

15           (G) Notwithstanding any provision of law to the contrary, the state treasurer  
16 is hereby authorized and directed to transfer \$21,468,862 from the Louisiana Mega-  
17 Project Development Fund to the Rapid Response Fund.

18           (H) Notwithstanding any provision of law to the contrary, the state treasurer  
19 is hereby authorized and directed to transfer \$50,000,000 from the State General  
20 Fund by Fees and Self-Generated Revenues of the Louisiana Department of Revenue  
21 to the Capital Outlay Savings Fund.

22           (I) Notwithstanding any provision of law to the contrary, the state treasurer  
23 is hereby authorized and directed to transfer \$3,180,990 to be comprised wholly of  
24 nonrecurring revenues out of the State General Fund from the Fiscal Year 2023-2024  
25 surplus, as recognized by the Revenue Estimating Conference, to the Capital Outlay  
26 Savings Fund.

27           (J) Notwithstanding any provision of law to the contrary, the state treasurer  
28 is hereby authorized and directed to transfer \$5,700,000 to be comprised wholly of  
29 nonrecurring revenues out of the State General Fund from the Fiscal Year 2022-2023  
30 surplus, as recognized by the Revenue Estimating Conference, to the Capital Outlay  
31 Savings Fund.

32           (K) Notwithstanding any provision of law to the contrary, the state treasurer  
33 is hereby authorized and directed to deposit into the Overcollections Fund from the  
34 revenues in the state general fund an amount equal to the amount of the State  
35 General Fund (Direct) for each line item appropriation in the Act that originated as  
36 House Bill No. 460 of the 2025 Regular Session of the Legislature that has a State  
37 General Fund (Direct) appropriation that is vetoed by the governor other than  
38 pursuant to his authority under Article IV, Section 5(G)(2) of the Constitution of  
39 Louisiana and that is not overridden by the legislature.

40           Section 2.(A) Notwithstanding any provision of law to the contrary, the state  
41 treasurer is hereby authorized and directed to transfer \$15,000,000 from the State

1 General Fund by Fees and Self-Generated Revenues of the Department of Insurance  
2 to the Louisiana Fortify Homes Program Fund.

3 (B) Notwithstanding any provision of law to the contrary, the state treasurer  
4 is hereby authorized and directed to transfer \$500,000 from the State General Fund  
5 (Direct) to the Fiscal Administrator Revolving Loan Fund.

6 (C) Notwithstanding any provision of law to the contrary, the state treasurer  
7 is hereby authorized and directed to deposit into the Overcollections Fund from the  
8 revenues in the state general fund an amount equal to the amount of the State  
9 General Fund (Direct) for each line item in the Act that originated as House Bill No.  
10 1 of the 2025 Regular Session of the Legislature that has a State General Fund  
11 (Direct) appropriation that is vetoed by the governor other than pursuant to his  
12 authority under Article IV, Section 5(G)(2) of the Constitution of Louisiana and that  
13 is not overridden by the legislature."

14 AMENDMENT NO. 8

15 On page 2, at the beginning of line 10, delete "Section 2." and insert "Section 3."

16 AMENDMENT NO. 9

17 On page 2, between lines 20 and 21 insert the following:

18 "Section 4. Within two weeks of the effective date of this Section, the  
19 division of administration shall coordinate with the state treasurer to transfer to the  
20 Water Sector Fund any unobligated balances as determined by applicable federal  
21 guidelines for the American Rescue Plan Act's State and Local Fiscal Recovery Fund  
22 Program, including any unspent interest balances."

23 AMENDMENT NO. 10

24 On page 2, at the beginning of line 21, delete "Section 3." and insert "Section 5."

25 AMENDMENT NO. 11

26 On page 2, at the beginning of line 26, delete "Section 4.This" and insert "Section 6.(A) This  
27 Section and Sections 1 and 3 through 5 this"

28 AMENDMENT NO. 12

29 On page 3, line 1, after "this" and before "Act", insert "Section and Sections 1 and 3 through  
30 5 of this"

31 AMENDMENT NO. 13

32 On page 3, after line 2, insert the following:

33 "(B) Section 2 of this Act shall become effective on July 1, 2025."
