1 AMENDMENT NO. 1

In Senate Committee Amendment No. 1, proposed by the Senate Committee on Finance and
adopted by the Senate on June 1, 2025, delete lines 3 through 8, and insert the following:

⁴ "Section 5. There shall be authorized a supplement in the same amounts authorized by ⁵ Section 6(A) of Act 775 of the 2024 Regular Session of the Legislature. This supplement ⁶ shall be payable in equal monthly installments. This supplement shall be funded by the ⁷ judiciary itself in Fiscal Year 2025-2026 only, and only in the event there is certification by ⁸ the Louisiana Supreme Court and the Louisiana Judicial Budgetary Control Board that the ⁹ judiciary has sufficient reserves to satisfy the obligation.

10 Section 6. The sum of Six Million and No/100 (\$6,000,000) Dollars is hereby appropriated from State General Fund by Statutory Dedications out of the Modernization and 11 12 Security Fund to the Louisiana Supreme Court for information technology and security 13 infrastructure improvements to be allocated as follows: Three Hundred Fifty Thousand and No/100 (\$350,000) Dollars to replace courtroom oral arguments audio and video equipment; 14 15 One Million One Hundred Thousand and No/100 (\$1,100,000) Dollars for additional 16 security fencing around the Louisiana Supreme Court Building; Two Million One Hundred 17 Twenty-Five Thousand and No/100 (\$2,125,000) Dollars to replace information technology 18 and security infrastructure nearing end of life; One Million Eight Hundred Twenty-Five 19 Thousand and No/100 (\$1,825,000) Dollars for courthouse security projects for the 20 Louisiana Supreme Court Building; and Six Hundred Thousand and No/100 (\$600,000) 21 Dollars for public portal access to the Case Management System of the Louisiana Protective 22 Order Registry, in the event that House Bill No. 461 of the 2025 Regular Session of the 23 Legislature is enacted into law."
