**EXPENDITURE EXPLANATION**

Proposed law will result in a significant increase in indeterminable expenditures; however, the timing of expenditures for this purpose is speculative and may occur outside of the five-year window of this fiscal note. Proposed law adds Ouiski Bayou State Park to the list of State Parks, although a timeline to acquire the property or transition it into a state park has not been determined. Future expenditures would require a State General Fund appropriation to initiate operation of the park and to support initial development activities, such as infrastructure construction, staffing, and resource planning to establish the park.

There is no anticipated direct material effect on governmental revenues as a result of this measure.
