Review Board; to provide for terms, conditions, and procedures;"

31	DISABILITY BENEFITS <u>- EXTRAORDINARY MEDICAL AND DENTAL EXPENSES</u>

33	§1668.1. Payment for extraordinary medical and dental expenses for firemen and
34	law enforcement officers
35	A. It is hereby declared to be the public policy of this state, under its police
36	power, to provide for certain extraordinary medical and dental expenses for firemen
37	and law enforcement officers determined to be injured as the direct and proximate
38	result of an injury arising out of and in the course of the performance of their official
39	duties.
40	B. As used in this Section, the following words have the following
41	meanings:

1	(1) "Board" means the Law Enforcement Officers and Firemen's Survivor
2	Benefit Review Board created and provided for in R.S. 40:1665.3.
3	(2) "Extraordinary medical and dental expenses" means any of the following:
4	(a) Medical expenses of the injured employee not covered by workers'
5	compensation coverage or by the health insurance plan provided by the employer.
6	(b) Dental expenses of the injured employee not covered by workers'
7	compensation coverage or by the health insurance plan provided by the employer.
8	(3) "Law enforcement officer" means the following:
9	(a) All sheriffs and deputy sheriffs in the state employed on a full-time basis.
10	(b) All members of the state police employed on a full-time basis.
11	(c) All municipal police officers in the state employed on a full-time basis.
12	(d) All university and college police officers at state universities and colleges
13	employed on a full-time basis.
14	(4) "Officer" includes firemen as defined in R.S. 40:1665 and law
15	enforcement officers as defined in Paragraph (3) of this Subsection.
16	C. In any case in which an officer is injured as the direct and proximate
17	result of an injury arising out of and in the course of the performance of their official
18	duties, the state risk director shall pay, as provided by R.S. 39:1533(A)(3), on behalf
19	of the officer any extraordinary medical and dental expenses incurred as determined
20	by the board.
21	D.(1) The board shall hear and decide by unanimous vote all claims for
22	extraordinary medical and dental expenses within sixty days after documentation is
23	received. The board may request any information necessary to make a determination
24	of eligibility for the payment of such expenses.
25	(2) Within ten days after the board has reached its decision, it shall send
26	notice of its decision to the officer by certified mail. If the board denies the claim,
27	the officer shall have one year from the date of denial to file suit against the state
28	through the board in the parish where the incident that brought about the injury
29	occurred. The date of denial shall be calculated as one year from the date of receipt
30	of the decision from the board.
31	E. If the board determines the officer qualifies for the benefit payable under
32	this Section, the board shall notify the state risk director.
33	F. The maximum benefit payable shall be fifty thousand dollars per injury
34	per officer.
35	G. No benefit shall be payable pursuant to this Section if any of the
36	following applies:
37	(1) The injury was caused by the intentional misconduct of the officer or by
38	the officer's intention to bring about his death, disability, or injury.
39	(2) The officer was voluntarily intoxicated at the time of his injury.
40	(3) The officer was performing his duties in a grossly negligent manner at
41	the time of his injury.
42	H. The board may adopt rules and regulations to implement the provisions
43	of this Section.
44	I. The provisions of this Section shall be applicable to extraordinary medical
45	or dental expenses incurred due to an injury arising out of and in the course of
46	performance of an officer's duties on or after January 1, 2023."
