1 AN ACT  
2 To amend and reenact R.S. 22:821(B)(2), (3)(b), (23)(a) and (b), and (24), relative to fees  
3 collected by the commissioner of insurance; to provide for fees relative to producers,  
4 claims adjusters, public adjusters, and the financial regulation of certain entities; to  
5 increase fees; to provide for an effective date; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 22:821(B)(2), (3)(b), (23)(a) and (b), and (24) are hereby amended  
8 and reenacted to read as follows:
