Existing law provides that the 19th Judicial District Court is comprised of East Baton Rouge Parish. Provides that the 19th Judicial District Court has 15 judges.

<u>Prior law</u> provided that the 19th Judicial District Court consisted of three election sections, each election section electing five judges.

<u>New law</u> repeals <u>prior law</u> and instead provides that the court shall consist of two election sections, each election section electing seven judges, and one judge elected at large.

Existing law (Act 145 of the 1994 3rd E.S. and Act 198 of the 2001 R.S.) provides that each judgeship be designated as a division.

<u>Prior law</u> assigned each division to one election section as follows:

- (1) Election Section 1: Divisions B, D, J, K, and O
- (2) Election Section 2: Divisions A, G, L, M, and N
- (3) Election Section 3: Divisions C, E, F, H, and I

<u>New law</u> repeals <u>prior law</u> and instead provides that the divisions be assigned to election sections as follows:

- (1) Election Section 1: Divisions A, D, J, K, L, M, and O
- (2) Election Section 2: Divisions C, E, F, G, H, I, and N

 $\underline{\text{New law}}$ further provides that the judgeship designated as Division B shall be elected at large.

<u>New law</u> specifies that precincts referenced in district descriptions are those precincts contained in the file named "2025 Precinct Shapefiles (01-16-2025)" available on the legislature's website. Provides that the 2025 Precinct Shapefiles are based upon those Voting Districts (VTDs) contained in the 2020 Census Redistricting TIGER/Line Shapefiles for the State of La. as those files have been modified and validated through the data verification program of the La. House of Representatives and the La. Senate to represent precinct changes submitted through Jan. 16, 2025, to the Legislature of La. by parish governing authorities.

New law also specifies that if any such precinct has been subdivided by action of the parish governing authority on a nongeographic basis or subdivided by action of the parish governing authority on a geographic basis in accordance with existing law, the enumeration of the general precinct designation shall include all nongeographic and all geographic subdivisions thereof. Further provides that the territorial limits of the districts as enacted shall continue in effect until changed by law regardless of any subsequent change made to the precincts by the parish governing authority.

Population data, statistical information, and maps are supplied for purposes of information and analysis and comprise no part of new law.
