SENATE BILL NO. 51

CRIME/PUNISHMENT. Creates the crime of fraudulent representation of military service or awards. (8/1/26)

1 AN ACT

2 To enact R.S. 14:67.30, relative to misappropriation without violence; to create the crime
3 of fraudulent representation of military service or awards; to provide for elements
4 of the crime; to provide for definitions and penalties; and to provide for related
5 matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 14:67.30 is hereby enacted to read as follows:

8 **§67.30. Fraudulent representation of military service or awards**

9 **A.(1) A person commits fraudulent representation of military service or**
10 **awards when he makes a false representation that he has received or otherwise**
11 **holds a military service record or award that was either revoked or not granted**
12 **to, achieved by, assigned to, or earned by the person with the intent to injure,**
13 **defraud, obtain economic gain, advantage, benefit, or secure any privilege for**
14 **himself or another.**

15 **(2) Whoever commits the crime of fraudulent representation of military**
16 **service or awards shall be fined not more than one thousand dollars, or**
17 **imprisoned for not more than six months, or both.**

1 **B. Whoever commits the crime of fraudulent representation of military**
2 **service or awards with regard to any of the following military awards or honors**
3 **shall be fined not more than five thousand dollars, imprisoned with or without**
4 **hard labor for not more than one year, or both:**

5 **(1) Congressional Medal of Honor as defined in 18 U.S.C. 704(c)(2).**

6 **(2) Distinguished-service cross awarded under 10 U.S.C. 7272.**

7 **(3) Navy cross awarded under 10 U.S.C. 8292.**

8 **(4) Air Force cross awarded under 10 U.S.C. 9272.**

9 **(5) Silver star awarded under 10 U.S.C. 7276, 8294, or 9276.**

10 **(6) Purple Heart awarded under 10 U.S.C. 1129.**

11 **(7) Combat Action Ribbon, Combat Action Badge, or Combat Action**
12 **Medal.**

13 **(8) A replacement of or duplicate of any of the awards listed in**
14 **Paragraphs (1) through (7) of this Subsection.**

15 **C. Whoever commits the crime of fraudulent representation of military**
16 **service or awards when the fraudulent representation results in the issuance of**
17 **a benefit reserved to active duty service members, veterans, or the family**
18 **members of active duty service members or veterans shall be fined not more**
19 **than ten thousand dollars, imprisoned with or without hard labor for not more**
20 **than five years, or both. In addition, the offender shall be required to pay full**
21 **restitution of the benefit received in violation of this Subsection.**

22 **D. As used in this Section:**

23 **(1) "Award" means any medal, service ribbon, ribbon device, badge,**
24 **rank insignia, or other honor awarded by the armed services or reserve forces**
25 **of the United States or the national guard of any state.**

26 **(2) "Service record" means the actual record compiled and maintained**
27 **by the armed services or reserve forces of the United States or the national**
28 **guard of any state that documents the service rank, deeds, achievements,**
29 **qualifications, or actions performed by a person during his time in service.**

- 1 **(3) "Veteran" means a person who has served in the armed services or**
 2 **reserve forces of the United States or the national guard of any state.**

Proposed law creates the crime of fraudulent representation of military service or awards and makes it unlawful for a person to make a false representation that he has received or otherwise holds a military service record or award that was either revoked or not granted, achieved, assigned, or earned with intent to injure, defraud, obtain economic gain, advantage, benefit, or secure any privilege for himself or another.

Proposed law provides that a person who commits the crime of fraudulent representation of military service or awards will be fined not more than \$1,000, or imprisoned for not more than six months, or both.

Proposed law provides that whoever commits the crime of fraudulent representation of military service or awards with regard to any of the following military awards or honors will be fined up to \$5,000, imprisoned with or without hard labor for not more than one year, or both:

- (1) Congressional Medal of Honor.
- (2) Distinguished-service cross.
- (3) Navy cross.
- (4) Air Force cross.
- (5) Silver star.
- (6) Purple Heart.
- (7) Combat Action Ribbon, Combat Action Badge, or Combat Action Medal.
- (8) A replacement or duplicate of any of these awards.

Proposed law provides that whoever commits the crime of fraudulent representation of military service or awards when the fraudulent representation results in the issuance of a benefit reserved to active duty service members, veterans, or the family members of active duty service members or veterans will be fined up to \$10,000, imprisoned with or without hard labor for not more than five years, or both. Proposed law further provides that the offender must pay full restitution of the benefit received in violation of proposed law.

Proposed law provides that:

- (1) "Award" means any medal, service ribbon, ribbon device, badge, rank insignia, or other honor awarded by the U.S. armed forces, reserve forces of the U.S., or the national guard forces of any state.
- (2) "Service record" means the actual record compiled and maintained by the U.S. armed

forces, reserve forces of the U.S., or the national guard forces of any state, that documents the service rank, deeds, achievements, qualifications, or actions performed by a person during his time in service.

- (3) "Veteran" means a person who has served in the U.S. armed forces, reserve forces of the U.S., or the national guard forces of any state.

Effective August 1, 2026.

Summary of Amendments Adopted by Senate

Senate Floor Amendments to engrossed bill

1. Adds the Combat Action Ribbon, Combat Action Badge, or Combat Action Medal to the proposed law list of military awards that may not be falsely claimed.
2. Adds intent as an element of the offense.
