Requires the posting of signs in student health centers at public schools, colleges, and universities to provide information on available pregnancy resources. (gov sig)

Present law requires the Office of Public Health (OPH) within the Louisiana Department of Health (LDH) to facilitate the establishment of school health centers, requires centers to be registered with OPH, and prohibits health centers from advocating abortion. Proposed law retains present law. Proposed law provides that LDH, or a designated nonprofit organization, produce and distribute signs for school health centers in public high schools and student health centers on public college and university campuses. Provides that signs include a website link to pregnancy information and resources listed on the LDH website and read "Pregnant? Help Is Available for You and Your Baby!" Provides that signs be at least 16 inches by 20 inches with large, easily readable font. Proposed law defines "designated nonprofit organization" as a private, tax-exempt nonprofit designated by the Secretary of LDH to assist in carrying out proposed law.
